Dear Brothers and Sisters,

As I mentioned in the last two bulletins, we are focusing on a section in the book *Church Money (Lessons from a Catholic Parish – Rebuilding the Way We Fund Our Mission)* for the next few weeks. It is a fascinating book and a good read. The chapter that really struck me was entitled "God's Guide for Giving: 5 Rules We Try to Live By." This week, we will look at Rule #3. Enjoy.



Rule 3: Tithe

"The payment of tithes is due to God and those who refuse to pay, usurp the property of another. Those who withhold them or hinder their payment shall be excommunicated, nor be absolved of this crime until full restitution is made" (*Council of Trent*).

In the second book of Samuel, King David is planning a worship ceremony to the Lord, so that a plague may be withdrawn from his people. Araunah, who owned the place where the altar was to be built, proposed to bequeath all the necessary worship offerings to the king. Instead, David establishes an important principle, insisting on purchasing the offering. He says, "I cannot sacrifice to the Lord my God burnt offerings that cost me nothing" (*2 Samuel 4:24*).

For the worship to be worship, it must cost us something.

A tithe is the gift of 10 percent of what one has or earns, which is given to honor God. Counted in the tithes are all our gifts in our place of worship as an act of worship. Tithing was established as the consistent standard of worship giving throughout the Bible, beginning in Genesis. Later, Jesus himself explicitly addresses tithing and commends it.

The third chapter of Malachi gives perhaps the clearest picture of the importance of the tithe. God says to the people, "Since the days of your ancestors you have turned aside from my statutes and have not kept them. Return to me, that I may return to you, says the Lord of hosts" (*Malachi 3:7*). God tells the Israelites that he had long ago established a law that they consistently failed to follow. That failure created a gap in their relationship with God, but not, it turns out, an unbridgeable one.

Then the Israelites ask a good question, "Why should we return?" God responds, "Can anyone rob God? But you are robbing me! And you say, 'How have we robbed you?' Of tithes and contributions!" (*Malachi 3: 7-8*). God considers tithing his due. He equates denying him the tithe to theft.

On the other hand, God promises: "Bring the whole tithe into the storehouse, that there may be food in my house. Put me to the test, says the Lord of hosts, and see if I do not open the floodgates of heaven for you, and pour down upon you blessing without measure!" (*Malachi 3:10*). God tells the Israelites to test him on exactly this point. And when they do, putting his teaching in action, they will see his protection and provision over the whole of their lives, including their finances.

Notice where God tells them to bring the tithes: to the storehouse. The storehouse was a dedicated room in the Temple for storing tithed grain. In other words, the tithe would have been brought directly to the place of worship. It was intended to support the Temple and the people who served there.

When it comes to tithing, many people conveniently argue that this is an Old Testament idea that has been done away with in the new covenant. They contend Jesus abolished it in the same way that he made all foods clean and healed people on the Sabbath. However, Jesus states in the Sermon on the Mount, "Do not think that I have come to abolish the law or the prophets. I have come not to abolish but to fulfill. Amen, I say to you, until heaven and earth pass away, not the smallest letter or the smallest part of a letter will pass from the law, until all things have taken place" (*Matthew 5: 17-18*). Throughout his ministry, Jesus' enemies accused him of all manner of offenses, including breaking the Sabbath. But no one ever once accused him of not tithing. Jesus never abolished the tithe, or even ever suggested it was no longer applicable to Christians. He consistently affirmed the teachings of the Hebrew scriptures. He did not come to repeal or replace them but to renew and restore them.

Elsewhere, Jesus says to the Pharisees, “Woe to you, scribes and Pharisees, you hypocrites. You pay tithes of mint, dill and cumin and have neglected the weightier things of the law: judgment and mercy and fidelity. [But] these you should have done, without neglecting others” (**Matthew 23:23**). Here, while visiting the Temple courts, Jesus goes on nothing less than a tirade against the scribes and Pharisees. It is a scathing rebuke of their poor leadership. Yet right in the middle of his intense criticism, he acknowledges their tithes. He explicitly commends the Pharisees for tithing, really the only positive observation he ever makes about them.

I hope you have found these rules something worthwhile to ponder. Next week we will look at *Rule 4: Give Beyond the Tithe*. You are in my daily thoughts and prayers. May God bless you with the very best this week.
